Hawm txog Cityview cov tsev neeg,

Tsev kawm ntawv ntawv nroog Minneapolis (MPS) yeej muab siab tiag los ua kom txhua tus menyuam kawm ntawv muaj txoj kev kawm zoo, kom txhua tus menyuam kawm ntawv thiaj ua tau mus zoo nyob rau hauv tsev kawm ntawv thiab hauv lub neej. Yuav xyuas kom koj tus menyuam ua tau mus zoo, peb teeb qhov yuav tsum kawm kom tau ntawd siab uas qhia tej peb qhia nyob rau hauv chav kawm. Nyob rau hauv kev kawm lub xyoo peb yuav saib ntau tus kev ntsuam xyuas los ntsuas es qhia seb peb cov tsev kawm ntawv uas tau zoo licas. Qhov no yuav ua rau peb ncav tau peb lub hom phiaj uas txhua tus menyuam kawm ntawv yuav ua tau zoo nyob rau hauv tsev kawm ntawv thiab hauv lub neej.

Xyoo no Cityview tau muab tso rau qhov hais tias continuous improvement school nyob rau ntawm tsoom fwm txoj cai Elementary and Secondary Education Act (ESEA). Qhov no vim yog lub tsev kawm ntawv nyob rau ntawm 25 feem pua ntawm cov tsev kawm ntawv titel I uas ua tau tsis zoo nyob rau ntawm lub xeev qhov Multiple Measurement Rating (MMR), uas ntsuas cov tsev kawm ntawv qhov cov menyuam kawm ntawv ua tau zoo, loj hlob ntawm kev kawm, qhov ua kom me rau ntawm qhov nrug ntawm kawm tau ntawv thiab cov kawm tiav kev kawm theem siab.

Continuous improvement schools yuav tsum siv tej ntaub ntawv uas qhia txog cov menyuam kawm ntawv txoj kev ua tau los ua ib qho hais tias needs assessment. Qhov needs assessment yog ib txoj kev uas peb saib xyuas lub tsev kawm ntawv tej ntaub ntawv es thiaj li paub txiav txim hais tias yuav txim kho peb lub tsev kawm ntawv licas. Peb yuav siv qhov pom ntawm qhov needs assessment los tsim qhov school improvement plan uas tsom kwm los pab kom txhua tus menyuam kawm ntawv ncav tau lawv lub peev xwm. Yuav kom ua tiav qhov hauj lwm tseem ceeb no, peb yuav tsim ib pawg uas los txhim kho uas muaj ntau leej uas muaj feem cuam nyob rau hauv, nrog rau cov niam txiv. Peb txhawb kom koj los ua ib tug ntawm pawg txhim kho no; yog hais tias koj txaus siab hu tus xov tooj hauv qab no.

Cov tsev neeg thiab ntawm ib cheeb tsam yog nyob rau hauv nruab nrab ntawm peb qhov kev npaj los txhim kho lub tsev kawm ntawv. Caws koj tuaj koom rau peb qhov State of the school thiab Title I qhov kev sib tham. Lub niam tswv yim ntawm qhov State of the School thiab Title I qhov kev sib tham uas yog ua ib xyoo ib zaug no yog los muab kev qhia rau niam txiv/cov siab xyuas txog seb tam sim no lub tsev kawm ntawv nyob licas thiab qhov School Improvement Plan. Lub tsev kawm ntawv yuav qhia qhov uas tseem ceeb rau nws, tej hom phiaj thiab tej tswv yim rau kev txhim kho thiab seb niam txiv yuav los nrog kom pab licas tau nyob rau hauv xyoo kev kawm. Qhov kev sib tham no yuav qhia kom tseeb txog lub niam tswv yim ntawm Title I thiab tej kev sib cuag mus los (sib tham) tas mus li nrog cov niam txiv/cov saib xyuas hais txog ntawm lawv cov menyuam txoj kev kawm mus tau licas. Yog hais tias qhov kev sib tham tseem tsis tau ua los yog koj tseem tsis tau txais tau kev qhia txog qhov kev sib tham, hu rau peb kom tau kev qhia txog hnuv uas yuav sib thiab lub sij hawm uas yuav sib tham ntawd.

Koj kev los koom thiab kev txhawb nqa yog ib qho tseem cheeb heev rau koj tus menyuam txoj kev kawm tau ntawv. Peb txhawb kom koj nrog koj tus menyuam tus nais khus tham kom paub txog tej kev zoo tshaj plaws uas koj yuav pab txhawb tau rau koj tus menyuam tej kev kawm nyob rau hauv chav kawm. Ntawm no yog ob peb yam uas koj yuav ua tau los txhawb nqa koj tus menyuam txoj kev kawm:

- Saib xyuas zoo kom koj tus menyuam mus kawm ntawv txhua hnuv thiab ncav sij hawm.
- Nrhaiv ib qho chaw ntsiag to rau koj tus menyuam ua nws tej ntaub cov los ua nram tsev thiab nyeem ntawv.
- Nrog koj tus menyuam thaum txog kev kawm ntawv (tsev kawm ntawv).
